Welcome To 2015! by David Schoenbrun, President

Welcome to 2015! And a special welcome to our newest members – those members of the former Local 292 (Santa Rosa, Napa, Vallejo, and points north to the Oregon border) who became members of Local 6 on January 1st.

SIZE MATTERS

Now that our jurisdiction rivals a respectably-sized European country, it's reasonable to ask just how we plan to manage such a territory with two nearly full-time officers and an office staff of five. On top of the new purely physical girth of Local 6, our acquisitions in the last two years of adjacent Locals to the north and south bring our total number of bargaining units to nearly 50. These are all permanent groups with contracts to be negotiated and maintained, musician memberships to be serviced, grievances to be resolved, and the daily grind of day to day, rehearsal

to rehearsal problems to be

addressed in a timely and

responsible manner.

And, in the words of our venerable legal counsel David Rosenfeld, "Organize, organize, organize!" This is the prime directive of a labor union, and the former Locals 153 and 292 bring with them a significant number of organizing targets that require considerable time and energy.

Add to those activities dealing with the needs of the recording and theatre communities, and you have a hefty job description, and what I like to describe as "never a dull moment." One plan we are likely to pursue in order to remedy the workload effects of our recent expansions on the officers involves an amendment to our Bylaws that officially increases the president and secretary-treasurer positions from their current 75% to 100%. More on that in the next issue of the Musical News.

What Do Dues Do? by Beth Zare, Secretary - Treasurer

It is that time of year when members are paying their annual dues to the Musicians Union Local 6. This got me

to thinking about what your dues really do. Musicians work hard for their money and I rarely run into anyone who likes to pay their union dues. Having said this, there are many good reasons to pay your dues:

- 1. Pays for professionals to bargain new contracts.
- 2. Pays for lawyers to pursue grievances or arbitrations on your behalf.
- 3. Allows for stewards on the worksite in case workers are treated unfairly.
- 4. Union gigs are often better gigs than non-union gigs.
- 5. Job security is protected through your union.

- 6. Raises are negotiated by your union.
- 7. The union pension plan is earning you money for retirement. (*see page 4*)

January was the month in which we offered a dues sale for regular members. This meant that there was a \$15 savings on annual dues. In the past, members would add a little something extra in their checks as a donation to TEMPO. There are fewer donations this year mainly due to the increase in online payments by credit

cards. TEMPO has started a new campaign requesting a commitment of \$1 per week from members. This can be paid in one lump sum of \$52. For more information on how TEMPO supports musicians' visit http://www.afm.org/member/page/id/5238

In conclusion, your dues are hard at work on your behalf while you work hard. Thank you again for supporting your union and being part of our collective force.



Recording Work

Local 6 is trying to stem the tide of non-union recording being done in our jurisdiction. Allowing such work to take place unchallenged can and will undermine our significant efforts to bring more union recording work to the Bay Area. Therefore, when receiving offers of recording work, all members should be sure to ask if it is being done under a union contract. Do not agree to offer your services for non-union recording projects. Members doing so are subject to board-imposed fines or expulsion. Think long-term, and think collectively!

Petition For 2014 Multi-Card Rebate

Effective January 1, 2015, members who belonged to three or more Locals throughout 2014 can petition the AFM Secretary-Treasurer for a "rebate equal to the per capita dues received by the Federation" for that

member's membership in each AFM Local in excess of two. (Members pay their Federation per capita dues as a portion of their Local annual dues. The Local forwards the member's per capita dues to the

Federation. Only the Federation's portion of the annual dues will be rebated).

No rebates will be issued until the AFM Secretary-Treasurer's Office

verifies that petitioning members held continuous membership in three or more Locals for the full prior year of 2014. No rebates will be issued until after February 1, 2015.

Taking Care Of Business

How To Get Pension On Your Gigs by Joe Rodriguez

Here are a few scenarios depicting how you can get pension for your jobs:

1. Whoever Is Paying (The Purchaser)Is Willing To Sign The LS-1.

Familiarize yourself with this very useful form. Your name goes in as the 'designee' meaning you are able to write the check and include yourself. It is good if you have the figures ready beforehand. Know what scale wages are and then calculate the pension contribution amounts at anywhere between 4.16% up to 16.35%. You will also need the social security numbers of the musicians in your band if they are not Local 6 members. If they are Local 6 members, we have their info in the office. This procedure can also work if you are a side musician playing in a band consisting of non-members. Ask the leader if they will sign the LS-1.

2. The Purchaser Does Not Want To Sign Anything, And Just Gives You Cash.

There are a few different ways to go with this:

- If they are just unsure of what the LS-1 form is, explain that it is internal pension fund paperwork only and that it does not go to any government agency or the IRS. If they will sign it and do not want to give you their social security number, don't press it. It'll still fly.
- Utilize a payroll service that is a union signatory, meaning they have an agreement in place with the pension fund. Give the payroll service all the money and they will pay the musicians, the Federal and State obligations, and write the pension and work dues checks. In fact, you could take all your cash monthly to a payroll service and have all your jobs processed this way. Remember, you must add the payroll service's fee into the total cost of the band up front.
- Incorporate yourself or become a Limited Liability Company (see nolo.com which sells forms and instruction

manuals). As a corporation or LLC, you can sign a Pension Participation Agreement thru the union and file a copy of your articles of incorporation. Now you are able to write the pension check for the band and include yourself.

• The leader (you) signs the LS-1 as the employer and pays the pension on the side musicians, keeping your portion in cash. You won't be able to pay pension on yourself but will have the satisfaction of helping someone else contribute to their pension.

What you cannot do:

- Make a pension contribution on your spouse.
- Have your spouse sign the LS-1 or Pension Participation Agreement.
- Have someone else in the band sign the LS-1 or PPA.
- Make pension contributions on jobs which did not take place.

FILING YOUR CONTRACTS

In addition to making a pension payment, you are able to pay work dues to Local 6 at the rate of 2.25%, based on the same scale. Send the signed LS-1 form, pension check and work dues check to the union. An officer signs 'for the union' and you are good to go!

Applying For Your Pension

Here are a few things to keep in mind regarding your pension:

You pension account automatically starts upon commencing your contributions and you reach \$750 in earnings for a calendar year. After five years of \$3,000 in earnings, you will become "vested". Make sure that the box on your form is marked vested. Then you are set and have a permanent account.

Keep checking your yearly pension statement to make sure all your

contributions are posted. The key is consistency. Also, never throw away check stubs, 1099's and W-4's as you may need them if a contribution does not show up. You may have to prove you worked for the employer in question.

If you go to www.afm-epf.org and get a username and password, you can look at your account on line. There is even a calculator that will tell you how much you may receive depending on how old you are when you retire. The two page application

form and information you will need is available online and accessible without a password. Be sure to fill out a beneficiary form and keep it updated. Check out the 'Summary Plan Description" for current guidelines.

You can apply as early as age 55 albeit for a lower benefit amount. There are also provisions for survivors, a disability distribution and a variety of scenarios you may be entitled to. Make sure the fund has your current contact information. They can be contacted by phone at 1-800-833-

8065. You may call us if you have any general questions about the fund but keep in mind that we are not directly connected with the pension fund as they are a separate entity. We do not have access to your account and cannot make any changes to your information.

David Albert Winters

With great sadness and deep gratitude for his life, we announce that David died peacefully with his family by his side following a sudden and unexpected heart attack. Born in Boston, Massachusetts, David grew up alongside five siblings in a household that celebrated music. It was there that his unfailing devotion to music began and where he taught himself guitar at an early age.



David was also a gifted thinker and problem solver and he earned a B.S. in Teaching and Mathematics from Salem State. He met his lifelong partner Merritt Tucker while in Eugene, Oregon and the two moved to Santa Cruz, California in 1979 where they settled for the remainder of David's life.

For 41 years, David and Merritt worked and played and raised their son and daughter, Bailey and Zoë, amongst countless friends and colleagues. He was often described as humble and quiet, yet David's work on behalf of peace and social justice was strong and courageous.

With hair swinging and rhythmic feet dancing to the beat, his fingers swept up and down the strings with expert precision. On guitar, he played jazz standards, traditional folk and blues, classical music and his own original work. On the mandolin, his specialties included Irish music and Italian classics. David's sweet and smooth

vocals, full and kind, will truly be missed.

His original compositions were used widely by theater companies and dance companies, including Mamalution Dance Collective. In addition, David contributed instructional pieces to Acoustic Guitar Magazine, to Guitar Player Magazine's prestigious 'Master Series,' and to Complete Guitarist (National Guitar Workshop). His acclaimed book, Natural and Artificial Harmonics for the Guitar, is a contribution to the field of harmonic theory and technique. He recorded many celebrated albums over the years and performed annual concerts at Kuumbwa Jazz Center with special appearances by his children.

For 29 years David served as Festival Coordinator for the Western Worker's Labor Heritage Festival. He was a dedicated member of the AFM Local 153 musician's union and worked many years as an officer of that Local. He also served as the Secretary/ Treasurer of the Santa Cruz Central Labor Council. At Cabrillo College, David was a beloved Choir Director at the Stroke And Disability Learning Center and a friendly and gifted Instructional Assistant in the Cabrillo College Math Learning Center (MLC). It was while receiving tutoring from David at the MLC that several EMT students responded to David's emergency with resuscitation and great care.

Though David was a gifted musician and devoted worker, his greatest joy was his family. He is remembered as his kids biggest fan and he is survived by: his life partner, Merritt; daughter Zoë; son Bailey and Bailey's partner Missy; sisters: Marsha, Susan, Patricia and Paula; his brother Jack; brothersin-law Mark and Charles Tucker; as well as in-laws, nieces, nephews and friends.

Brother David Winters and I worked together as Local 153 officers and as Irish musicians for about 15 years. A major achievement of David's Local 153 work was advancing the Single Engagement Pension Agreement into wider use. David's contribution to the AFM International included serving as Chair of the TEMPO Committee for several Conventions. David was a dedicated and most compassionate union leader.

Our music collaboration began almost by default. Upon his suggestion, one day I brought my fiddle to the office. David showed up with an extremely loud 1930's Dobro mandolin. He and I Jammed on some

Irish tunes for a while, and just like that we had formed The O'Daveys Irish Band. David made our business card: a wooden nickel printed with a black shamrock. Pounding out Reels, and Jigs, and singing Rebel songs with David in San Francisco's Irish pubs were some of my greatest joys as a musician.

I attended the celebration of David's life on January 3rd, in Santa Cruz. At that event, I felt the beautiful and wonderful depth and strength of David's surviving family. My heart goes out to Merritt, Bailey, Zoe, and Missy. May the circle be unbroken...
