WE CAN DO IT!





s I reflect on the first two years of serving as your Lead Organizer, I am filled with the spirit of Rosie the Riveter and have an overwhelming, "We can do it!" attitude. I have spent time with many of you; seen you build new relationships, develop your organizing skills, and watch many of you embrace your power and become leaders in our movement. The great Civil Rights Organizer Ella Baker refers to this as "spadework" or "routine or difficult preparatory

work." It is this work of relationship deepening, skill sharpening, and power building that will serve as our foundation for your wins to come.

1 LEARN IT, DO IT, TEACH IT

Many of you have learned and executed skills like the structured organizing conversation, how to facilitate meetings, various processes for strategizing campaigns, and planning an action. If we want to take our power and ability to win gains for musicians in the Bay Area to the next level, we must adopt the "learn it, do it, teach it" culture within our community. This is critical. Our movement will require hundreds of leaders over the next few years. If we want to be a community that can fix any problem musicians face, we need to add the third pillar of this method and see members teaching members organizing skills in the year of 2024.

2 STRUCTURE TESTS

Whether you planned a workshop, organized a survey, or put on a public panel, many of you participated in one of the core ingredients of organizing, the structure test. A structure test is any time you take action and you can assess how many of your fellow workers you are able to bring together. Every structure test should build off of the last and in every community in 2023, we saw our commitment to take action together grow. But we have a long way to go. If in 2023 10% of our membership participated by taking an action, or sat on a committee, or served as a Labor Council Delegate, we have to ask ourselves what we could accomplish if 25%, 50%, or even 100% of the musician community was participating in some level of the movement.

ALL ABOUT LOVE

You don't have to organize with musicians for very long to begin to sense divisions, mistrust, and disengagement within our community. In these two years, many of you have opened up with me about these realities and how this contributes to your fear of organizing and belief that we can't win change. Is there too much water under the bridge? Have we grown too far apart to ever be whole again? After my first year (2022), in the face of this reality that we have a long journey ahead of us to heal this division, I prepared myself by reading All About Love by bell hooks. They suggest that organizing communities do not conceptualize love as ephemeral or indescribable. That instead we understand love as real actions within our community, actions like consistency, transparency, grace, and justice to name a few. It is these values that I brought into my conversations with you in 2023 and I saw this strategy first hand begin to break down the apathies listed about. I offer it to you as a strategy to begin to heal the divisions and mistrust, and bring us back together; be consistent, act transparently, offer grace, and stand for justice.

In this newsletter, you will find delegate information on to explore a few of the actions, campaigns, and buckets of work that are being tackled by members of our local. As you read through, I challenge you to see yourself in our movement this year. If we want to ensure that exploitation is ended in the music industry, this is the demand it will require. I look forward to the next two years and I am confident that our capacity to fight and win against bigger challenges will grow.



Dr. Vincent Pierce is new to the Bay Area from Austin, Texas. Vincent is a harpist, composer, teacher, and a leader in the harp community. He holds degrees from Baylor University, where he received a Bachelor of Music Education degree, and The University of Texas at Austin, where he received his Master's and DMA degrees in harp performance. Vincent is an experienced orchestral harpist, having performed with orchestras throughout Texas. He currently holds the principal harp position with West Texas Symphony, with whom he performed Mozart's Concerto for Flute and Harp in 2022, and has performed with Waco Symphony, Dallas Winds, Corpus Christ Ballet, and many others. In addition to orchestral performance, Vincent is an avid performer of chamber music and new music. He performs with his partner, Dr. Alan Berquist (flute), with whom he will premiere his new piece for electroacoustic harp and amplified flute at the National Flute Association Convention in San Antonio in August 2024. Vincent is currently working on an album of original music for electroacoustic harp which will be released in 2025. A community-minded musician, Vincent is also a board member for the Bay Area Chapter of the American Harp Society and has served on the board of directors of the American Harp Society at the national level.

Mario Guarneri

Mario Guarneri is a musician who has "done it all", from playing Dixieland jazz with Louis Armstrong at the age of thirteen to fifteen seasons with the Los Angeles Philharmonic under the batons of Zubin Mehta and Carlo Maria Giulini. He has toured Europe with the Los Angeles Brass Quintet and performed with the New York Philharmonic, the San Francisco Symphony, Radio City Music Hall and the Barnum and Bailey Circus. Mr. Guarneri has recorded solo albums on the Crystal and Nonesuch labels, one of which was nominated for the Prix de Rome. For a decade, Mario was the principal trumpet with the Los Angeles Chamber Orchestra and has played on over 400 TV and motion picture soundtracks, including solo performances on Lonesome Dove and Godfather III. He has taught trumpet for over 50 years, and is currently a trumpet instructor at the San Francisco Conservatory of Music. Guarneri also performs regularly with his jazz quartet in the San Francisco

area and has recorded four jazz CDs. In 1986 he developed the Buzz Extension and Resistance Piece (B.E.R.P.) for all brass instruments, a dynamic advancement in brass pedagogy. Since then, he has lectured extensively on the BERP concept. In recent years, he has presented lectures at the International Trumpet Guild, the New York Brass Conference, and numerous state and regional music conventions across the country. Guarneri has taught master classes in Asia and Europe, and has established a worldwide reputation as a creative musician of the highest level. His most recent project, Jazz in the Neighborhood, www.jazzintheneighborhood.org, is a non-profit bringing together on the bandstand, emerging young performers, and local jazz artists in alternative neighborhood venues.

John N. Fisher received his BA from Loyola University. John has held faculty positions at the San Francisco Conservatory of Music Preparatory Dept., The East Bay Center of Performing Arts, and Blue Bear Music School. John is an active Freelance player in a variety of Latin, Rock and Jazz groups. He has been Local 6's delegate to the San Francisco Labor Council since 2008 and is also a delegate to the AFM Triennial Convention.

A GRASSROOTS CAMPAIGN TO IMPROVE WORKING CONDITIONS FOR MUSICIANS

FAIRPLAYMUSIC.ORG

n Spring 2024 Musicians and those who care about a vibrant live performance scene in the Bay Area are piloting the Fair Play Initiative, a grassroots campaign to improve working conditions for Musicians in Bay Area cities; recognizing our key role as professionals that provide the backbone of local, regional and international culture.

Fair Play 's first step is to partner with selected cities to establish a guaranteed pay "floor" secured through a Prevailing Wage ordinance in city Charters. It would not put a "ceiling" on what Musicians are paid to work on municipally-financed events, series, and festivals but rather standardize a minimum rate to help eliminate unclear or exploitive pay practices that can't sustain Musicians sufficiently to live in and contribute their craft to the very expensive Bay Area.

Modeled after the IATSE prevailing wage ordinance, passed in SF 2004, the Fair Play Initiative will introduce and see enacted robust Prevailing Wage legislation for Musicians in Mountain View, Oakland, Richmond and San Francisco in 2024.

Following up on this prevailing wage effort, Fair Play will further shore up Musicians' working conditions and opportunities: initiate city-based fair procurement standards and benefits along with other city-based support favorable to venues, community agencies, and producers who adhere to these protocols (such as permitting help and grants) to help venues & producers who strive to treat Musicians fairly.

FAIR PLAY INITIATIVE NEXT STEPS INCLUDE

- Working for equity in booking, full disabled access and professional protections for all working Musicians.
- After Musicians are added to cities' Prevailing Wage ordinances each city will begin the research phase where a fair prevailing wage framework is set. Fair Play will inform this activity with resources, benchmarks and best practices guidelines for pay, professional protections, equity booking and access for disabled Musicians.
- Include cultural producers in the collaborative work to strengthen a sustainable music scene.

We know that a professional, respectful working environment for Musicians will strengthen the whole lively arts landscape, from the workers up, for generations to come. However, unless we act now, together, a signature element of Bay Area culture could go silent.

Bill Harvey- Alameda Labor Council Delegate

We Exist. The first time I introduced myself at the New Delegate Orientation another participant (Teamsters) said he didn't know musicians had a union. As I started attending monthly meetings, often in a Local 6 T-shirt, I started getting approached by other delegates who were interested in what we do and how we work. I remember a conversation with an apprentice from the International Brotherhood of Electrical Workers - in her workplaces the employer provides tools, and she was wondering how we could work union if we brought our own instruments. I realized that she was interested in the distinction between employees and independent contractors which was important to both of us. I told her that when musicians work in the industrial setting (eg. symphonic or broadway) we have no control over scheduling, repertoire, the notes we play or even when to breath, which would pass the Borello Test.

Political Action (Cold Calling and Door Knocking). Working on campaigns involves skills similar to what many of us do to keep ourselves gigging. In order to stay alive in the music business you have to be willing to approach people, have good conversations, and be willing to ask for something. I've learned that winning elections isn't about arguing with your relatives at Thanksgiving.

It's about finding people who agree with you and encouraging them to vote.

> Community Service. Sometimes workers need help with their contract fights - if a small bargaining unit goes out on strike it won't gain much attention. I when a Bakers Union members struck at the Red Ropes factory in Union City (where I used to work with high school trumpeters). Local politicians ironically took the side of management. The workers were demoralized and only had a handful of people standing outside the plant day and night. I volunteered to show up at 5:00am to block a busload of scabs brought in to replace the strikers. With the help of burly security guards (from Oregon) the van got through, but the media started to take notice and the Bakers got their contract.

John Fisher, San Francisco Labor **Council Delegate**

As a member of the San Francisco Labor Council for the past 15 years, I have had the opportunity to engage with other labor unions and coalitions and help maintain Musician Local 6's presence in the labor movement. As Professional musicians, we are workers too, and must retain our strong alliance with the labor community.

Jimmy Kelly, Alameda Labor Council Delegate

I am a currently adelegate for the Alameda Central Labor Council (CLC) for local 6 and have been a delegate for the South Bay the Monterey Bay and the Santa Cruz County labor councils! Serving as a Chattanooga Labor Council from AFM Local 80 is how I learned my first skills as an organizer. By attending actions with bus drivers, college professors, stagehands, boilermakers, and all sorts of fellow workers, I learned and brought those strategies back to the AFM. By participating as a Labor Council Delegate externally, you can grow our power internally as well.

David Borough- South Bay Labor Council Delegate

I first became involved with the Santa Clara County Labor Council in the late 1970's. I was working with the San Jose Committee in Solidarity with El Salvador. (El Comite). We had a strong emphasis on labor, and that brought me to attend Labor Council meetings. The Santa Clara County Labor Council, during those years, pretty much had it's own foreign policy.

In 1997, I was elected to the office of Secretary, of the San Jose Federation of Musicians: AFM Local 153. With that position I became a delegate to the Santa Clara County Labor Council (now the South Bay Labor Council), for 15 years. After an absence of three years following the merger with Local 6 I was appointed to the South Bay Labor Council, and have continued to represent Local 6 at monthly meetings.

The Labor Council community, solidarity, and commonality of progressive purpose that I have experienced over the years; has been and continues to be a source of nourishment for my soul. We have campaigned, marched, rallied, struck, and celebrated causes, candidates, and victories. I have worked to bring top flight Union Musicians to events, memorials, picnics, and celebrations. It has given, and continues to give me great pride and joy, to be with my union siblings, as we hear AFM Musicians give top quality performances, as they receive union scale, pension, and working conditions. I have also worked with many Musicians, to organize the unorganized in an effort to better the lives of Working Musicians...

Ithough Hollywood had awakened to the tremendous advertising and promotion potential of radio by the late 1930's, the networks maintained a strong presence in San Francisco. Many network shows originated here and some Hollywood-based productions such as The Bing Crosby Program would often broadcast from San Francisco because the stars enjoyed visiting the city. Since Mutual Don Lee did not yet have a large studio facility in Hollywood, their San Francisco operation continued to be of prime importance. CBS wanted to increase their control in San Francisco and attempted to buy their local affiliate KSFO. When that fell through, they bought KQW in 1941 (which later became the KCBS we know today).

It was left to the original pioneer, NBC, to make the most dramatic statement of confidence in San Francisco. On April 26, 1942, they opened San Francisco's "Radio City" to house both the NBC Red and Blue networks plus local stations KPO and KGO. It was a building of strikingly modern yet timeless design with the very latest, most luxurious studio facilities including the City's largest studio accommodating an audience of 100 or more, two medium sized studios, one for organ and one for orchestra, and seven smaller studios. A grand lobby and stairway leading to the upper floors let visitors see the operation of master control, news room, and recording department through glass panels. There was a huge music library and workspace for arrangers and copyists. NBC's broadcasting palace was a major investment justified, I believe, by sophisticated New York investors and executives who wanted NBC to have the strongest presence in the leading city of the West.

NBC's Red network musical directors were Carl Kalash followed by Tony Freeman. The large staff orchestra was supplemented with members of the San Francisco Symphony for The Standard Hour, Music Director at the Blue network was Phil Bovero with a separate staff orchestra. In 1942, anti-trust law forced NBC to divest itself of its Blue network. It continued in operation as simply "The Blue Network" until it was later re-organized as the American Broadcasting Company. KGO and ABC stayed in the Radio City building operating much as they had before the divestiture.

Network radio continued with live music broadcasting until the late 1950s. To learn more about the programs and personnel of the last decade, read my article in the August 2004 Musical News.
